It is proposed to fill up one post of Staff Car Driver (Ordinary Grade) in the Level-2 of Pay Matrix, Rs.19900-63200/- (as per 7th CPC) in Central Fertiliser Quality Control & Training Institute, Faridabad (a Sub-ordinate Office under the administrative control of Department of Agriculture & Farmers Welfare) on deputation/absorption basis.

#### Eligibility conditions : Deputation or absorption : 2.

From amongst the regular Group 'C' employees in Pay Band- 1, Rs.5200-20200/- plus Grade Pay of Rs.1800/- (pre-revised as per 6th CPC) in the National Centre of Organic Farming, Ghaziabad including its Regional Centres and Central Fertiliser Quality Control & Training Institute, Faridabad including its Regional Laboratories, who possess valid driving license for motor car on the basis of a driving test to assess the competence to drive motor cars, failing which from officials holding the post of Dispatch Rider on regular basis or regular Group 'C' employees in Pay Band 1, Rs.5200-20200/- plus Grade Pay of Rs.1800/- (pre-revised as per 6<sup>th</sup> CPC) in other Ministries of the Central Government, who fulfill the necessary qualifications as mentioned below:-

Desirable

- Three years service as Home Guard or Civil Volunteers.
- For Armed Forces Personnel on Deputation or re-employment: The Armed Forces a) Personnel due to retire or who are to be transferred to reserve within a period of one year and having the requisite experience and qualifications prescribed shall also be considered. Such persons would be given deputation terms up to the date on which they are due for release from the Armed Forces; thereafter they may be continued on re-employment.

Note: The period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization or Department of the Central Government shall ordinarily not exceed three years. The maximum age limit for appointment by deputation or absorption shall be "not exceeding fifty six years" as on the closing date of receipt of applications. formale
